Dear Shareholders,

- In light of the COVID-19 pandemic and as part of the safety measures, the 49th AGM of the Company will be conducted on a fully virtual basis via Remote Participation and Electronic Voting facilities (collectively referred hereinafter as “RPEV” or “Virtual AGM”) via online meeting platform at <https://web.lumiagm.com> as provided by Boardroom Share Registrars Sdn Bhd in Malaysia.
- According to the Revised Guidance Note and FAQs issued by the Securities Commission Malaysia on 1 June 2021, an online meeting platform can be recognised as the meeting venue or place under Section 327 (2) of Companies Act 2016 provided that the online platform is located in Malaysia. No shareholders/proxy(ies) from the public will be physically present at the meeting venue

4. No Vouchers / Door Gifts

There will be **no voucher(s) or any door gift(s)** for shareholders/proxies who participate in the 49th AGM.

5. Entitlement to Participate and Vote

In respect of deposited securities, only members whose names appear on the Record of Depositors on **14 June 2021** (General Meeting Record of Depositors) shall be eligible to participate in the AGM or appoint proxy(ies) to participate and/or vote on his/her behalf.

6. Proxy Form

Shareholders are encouraged to go online, participate, and vote at the 49th AGM using remote participation and electronic voting facilities. If you are not able to participate in the virtual AGM, you can appoint the Chairman of the meeting as your proxy and indicate the voting instructions in the proxy form.

You may download the Proxy Form for the AGM from our website at www.nstp.com.my/49thAGM.

Please ensure that the original form is deposited at the Share Registrar's office at Ground Floor or 11th Floor, Menara Symphony, No. 5, Jalan Prof. Khoo Kay Kim, Seksyen 13, 46200 Petaling Jaya, Selangor Darul Ehsan, Malaysia not less than 48 hours before the time appointed for holding the meeting. We do not acknowledge receipt of the Proxy Form.

Alternatively, the Form of Proxy can also be lodged electronically via "Boardroom Smart Investor Portal" at <https://investor.boardroomlimited.com/> not less than 48 hours before the time appointed for the holding of the meeting. Kindly refer to the procedure for Electronic Lodgement of Form of Proxy below.

Electronic Lodgement of Form of Proxy

Step 1 – Register Online with Boardroom Smart Investor Portal (for first time registration only)

[Note: If you have signed up with Boardroom Smart Investor Portal, you are not required to register again. You may proceed to Step 2 – eProxy Lodgement.]

- Access website <https://investor.boardroomlimited.com/>
- Click <<**Register**>> to sign up as a user.
- Complete registration and upload softcopy of MyKAD (front and back) or Passport in JPEG, PNG or PDF format.
- Please enter a valid email address and wait for email verification from Boardroom.
- Your registration will be verified and approved within one (1) business day and email notification will be provided to you.

Step 2 – eProxy Lodgement

- Access website <https://investor.boardroomlimited.com/>
- Login with your User ID and Password given above.
- Go to “**Corporate Meeting**” and browse the Meeting List for “**THE NEW STRAITS TIMES PRESS (MALAYSIA) BERHAD (49TH) ANNUAL GENERAL MEETING**” and click “**Enter**”.
- Click “Submit eProxy Form”
- Read the terms & conditions and confirm the Declaration.
- Enter your CDS Account Number and indicate the number of securities.
- Appoint your proxy(ies) or the Chairman of the Meeting and enter the required particulars for your proxy(ies).
- Indicate your voting instructions – FOR or AGAINST, otherwise your proxy(ies) will decide your votes.
- Review and confirm your proxy(ies) appointment.
- Click submit.
- Download or print the eProxy Form acknowledgement.

7. Revocation of Proxy

If you have submitted your Proxy Form and subsequently decide to appoint another person or wish to participate in our virtual AGM by yourself, please write in to bsr.helpdesk@boardroomlimited.com to revoke the earlier appointed proxy 48 hours before the meeting.

8. Voting Procedure

- i. The voting will be conducted by poll. The Company has appointed Boardroom Share Registrars Sdn Bhd as Poll Administrator to conduct the poll by way of electronic voting (e-Voting). The Company will also be appointing Boardroom Corporate Services Sdn Bhd as Scrutineers (“Scrutineers”) to verify the poll results.
- ii. During the virtual AGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules. The voting session will commence as soon as the Chairman calls for the poll to be opened and until such time when the Chairman announces the closure of the poll.
- iii. For the purposes of this virtual AGM, e-Voting will be carried out via personal smart mobile phones, tablets or personal computer/ laptops.
- iv. There are 2 methods for members and proxies who wish to use their personal voting device to vote remotely. The methods are:-
 - a) Launch Lumi AGM by scanning the QR code given to you in the email along with your remote participation User ID and Password; or
 - b) Access to Lumi AGM via website URL <https://web.lumiagm.com/>.
- v. The Scrutineers will verify the poll result reports upon the closing of the poll session by the Chairman. The Scrutineers will announce the results thereafter, and the Chairman will declare whether the resolutions put to the vote were successfully carried or not.
- vi. In accordance with the Company’s Constitution, members are entitled to vote at the virtual AGM either personally or by proxy, based on the General Meeting Record of Depositors.

9. Steps for registration for remote participation and electronic voting

- i. Please note that the Remote Participation and Electronic Voting is available to
 - (i) Individual member;
 - (ii) Corporate shareholder;
 - (iii) Authorised Nominee; and
 - (iv) Exempt Authorised Nominee.
- ii. You will be able to view a live webcast of the AGM proceedings, pose questions to the board, and submit your votes in real-time whilst the meeting is in progress.
- iii. Kindly follow the steps below on how to request for a login ID and password. Please note that shareholders are required to request the Login ID and password if you intend to participate in the virtual AGM.

Step 1 – Register Online with Boardroom Smart Investor Portal (for first time registration only)

[Note: If you have already signed up with Boardroom Smart Investor Portal, you are not required to register again. You may proceed to Step 2. Submit request for Remote Participation user ID and password.]

- a. Access website <https://investor.boardroomlimited.com/>
- b. Click <<Register>> to sign up as a user.
- c. Complete registration and upload softcopy of MyKAD (front and back) or Passport) in JPEG, PNG or PDF format.
- d. Please enter a valid email address and wait for Boardroom's email verification.
- e. Your registration will be verified and approved within one business day and an email notification will be provided.

Step 2 – Submit Request for Remote Participation User ID and Password

[Note: The registration for remote access will be opened on 4 June 2021]

- Select “Corporate Meeting” from main menu and select the correct Corporate Event “**THE NEW STRAITS TIMES PRESS (MALAYSIA) BERHAD (49TH) ANNUAL GENERAL MEETING**” and click “Enter”
- Click “Register for RPEV”
- Read and agree to the terms & condition.
- Enter your CDS Account and thereafter submit your request.

Corporate Shareholders, Authorised Nominee and Exempt Authorised Nominee

- Write in to bsr.helpdesk@boardroomlimited.com by providing the name of Member, CDS Account Number accompanied with the Certificate of Appointment of Corporate Representative or Form of Proxy to submit the request.
- Please provide a copy of Corporate Representative’s MyKad (Front and Back) or Passport in JPEG, PNG or PDF format as well as his/her email address.

You will receive notification(s) from Boardroom that your request(s) has been received and is/are being verified.

- a. Upon system verification against the General Meeting Record of Depositories as at 14 June 2021, you will receive an email from Boardroom either approving or rejecting your registration for remote participation.
- b. You will also receive your remote access user ID and password along with the email from Boardroom if your registration is approved.
- c. Kindly be informed that if you are registering for NSTP 49th Virtual AGM, you will be receiving 1 email from Boardroom.
- d. Please note that the closing time to submit your request is at 10.00 a.m. (AGM) on 19 June 2021 (48 hours before the commencement of the respective virtual AGM).

Step 3 – Login to Virtual Meeting Portal

[Please note that the quality of the connectivity to Virtual Meeting Portal for live web cast as well as for remote online voting is highly dependent on the bandwidth and the stability of the internet connectivity available at the location of the remote users.]

- a. The Virtual Meeting Portal will be open for login starting an hour (1 hour) before the commencement of AGM at 9.00 a.m. on 21 June 2021.
- b. Follow the steps given to you in the email along with your remote access user ID and password to login to the Virtual Meeting portal. (Refer to Step 2(b) above)
- c. The steps will also guide you how to view live web cast, ask questions and vote.
- d. The live web cast will end and the Messaging window will be disabled the moment the Chairman announces the closure of the AGM.
- e. You can now logout from Virtual Meeting Portal.

- iv. Shareholders who are unable to participate in our virtual AGM are encouraged to appoint the Chairman of the Meeting to vote on their behalf. You may use Boardroom Smart Investor Portal to submit your proxy appointment (Refer to note 6 - Electronic Lodgement of Form of Proxy above).

10. Participation through Live Webcast, Question and Voting at the virtual AGM

The Chairman and the Board of Directors will endeavour their best to respond to the questions submitted by shareholders which are related to the resolutions to be tabled at the 49th AGM, as well as financial performance of the Company.

Shareholders may proceed to cast votes on each of the proposed resolutions, to be tabled at the 49th AGM, after the Chairman has opened the poll on the resolutions. Shareholders are reminded to cast their votes before the poll is closed.

11. Presentation at the virtual AGM

Shareholders who participate in the virtual AGM are able to view the Company's presentation or slides via the live webstreaming.

12. Procedure of the virtual AGM

The Login User Guide for participation, posing questions and voting at the 49th AGM, will be emailed to you together with your remote access user ID and password once your registration has been approved.

You must ensure that you are connected to the internet at all times in order to participate and vote when the AGM has commenced. Therefore, it is your responsibility to ensure that connectivity for the duration of the meeting is maintained. Kindly note that the quality of the live streaming is dependent on the bandwidth and stability of the internet connection at the location of the remote participant.

13. Communication Guidance

Shareholders are also reminded to monitor the Company's website and announcements for any changes to 49th AGM arrangements.

14. No Recording or Photography

STRICTLY no recording or photography of the 49th AGM proceedings is allowed.

15. Pre-Meeting Submission of Questions to the Board of Directors

To administer the proceedings of the AGM in orderly manner, Shareholders may before the AGM, submit questions to the Board of Directors via email to nstpcorpcomm@mediaprima.com.my not later than 14 June 2021 at 10.00 a.m. The Board of Directors will endeavour to address the questions received at the AGM.
